 21 Defendants in this civil action, by and through undersigned counsel, hereby submit the  
 22 following responses to Plaintiffs' Notice To All Defendants Pursuant to Fed. R. Civ. P. 30(b)(6):  
 23

24 **GENERAL RESPONSE**

25 1. The information submitted herewith is being provided in accordance with the  
 26 Federal Rules of Civil Procedure which permit the discovery of any matter not privileged that is  
 27 relevant to the subject matter of this civil action. Fed. R. Civ. P. 26(b)(1). Accordingly,  
 28

1 Defendants do not, by providing such information, waive any objection to its admissibility on the  
2 grounds of relevance, materiality, or other appropriate ground.

3 2. The responses supplied herein are not based solely on the knowledge of the  
4 executing party, but include the knowledge of the Defendants, their agents, employees,  
5 representatives, and attorneys, unless privileged.  
6

7 3. To the extent that Defendants produce witnesses in response to Plaintiffs' notice to  
8 all Defendants pursuant to Fed. R. Civ. P. 30(b)(6) ("Notice"), Defendants do not concede that  
9 the testimony requested is relevant to this action. Defendants expressly reserve the right to object  
10 to further discovery of the subject matter of the request for testimony and the introduction into  
11 evidence of any testimony in response to this Notice.  
12

### 13 GENERAL OBJECTIONS

14 1. Defendants object to Plaintiffs' Notice, including all definitions and instructions  
15 contained therein, to the extent they seek to impose obligations beyond those specified under the  
16 Federal Rules of Civil Procedure or other applicable rules. All of Defendant's responses to the  
17 Notice herein are subject to and without waiver of this objection.

18 2. Defendants object to Plaintiffs' definition of "DOCUMENTS" to the extent that it  
19 encompasses electronic mail or other electronic records that are not in word-searchable format,  
20 including, but not limited to, any computer backup tapes. Such a definition renders any  
21 corresponding requests unduly burdensome and not reasonably calculated to lead to the discovery  
22 of admissible evidence, and the burden of any such proposed discovery outweighs its likely  
23 benefit.  
24

25 3. Defendants object to Plaintiffs' definition of "TEST PROGRAMS" as overly  
26 broad. The term "TEST PROGRAM" is defined to include, "without limitation," specifically  
27 identified test programs "and any other program of experimentation involving human testing of  
28

1 any substance[.]” Such a definition renders any corresponding requests unduly burdensome and  
2 not reasonably calculated to lead to the discovery of admissible evidence, as this definition has  
3 the potential to encompass clinical trials and other human tests in any setting, under any  
4 circumstances, and within any time frame. As most literally responsive records are wholly  
5 unrelated to the subjects of this litigation, Defendants have limited their document production to  
6 relevant documents pertaining to the specified test programs and other chemical or biological  
7 testing involving service members conducted in conjunction with the Edgewood Arsenal area of  
8 Aberdeen Proving Ground, Maryland, Fort Detrick, Maryland and Fort Ord, California.  
9

10 4. Defendants object to Plaintiffs’ Notice to the extent it requests information that is  
11 not reasonably calculated to lead to the discovery of admissible evidence.  
12

13 5. Defendants object to providing any files, records, reports, and any other papers and  
14 documents pertaining to any individual other than the individually named Plaintiffs to the extent  
15 that such information is protected by the Privacy Act, 5 U.S.C. § 552a, the Health Insurance  
16 Portability and Accountability Act of 1996 (“HIPAA”), 42 U.S.C. § 1320d-2, the HIPAA Privacy  
17 Rule, and/or 45 C.F.R. parts 160 and 164. Defendants further object to Plaintiffs’ Notice to the  
18 extent it seeks information protected from disclosure by the attorney-client privilege, the work  
19 product doctrine, deliberative process, or any other applicable privilege or immunity recognized  
20 under statute, regulation or applicable case law.  
21

22 6. Defendants object to Plaintiffs’ Notice to the extent it seeks information not  
23 known or reasonably available to Defendants or to the extent they seeks information that is  
24 publicly available, and/or that is equally or more readily available to Plaintiffs.  
25

26 7. Defendants object to Plaintiffs’ Notice to the extent that it seeks information that is  
27 classified pursuant to Executive Order 12,958 and subject to the state secrets privilege or  
28 otherwise subject to the state secrets privilege.

1           8. Defendants further object to the instructions and definitions set forth in Plaintiffs'  
2 Notice to the extent they impose obligations on Defendants that require disclosures of information  
3 protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g, which  
4 authorizes the CIA to protect the organization, functions, names, official titles, and salaries of all  
5 of its employees notwithstanding any other provisions of law. All of Defendants' responses to  
6 Plaintiffs' Notice herein are subject to and without waiver of this objection.  
7

8           9. To the extent that Defendants identify witnesses in response to a give topic of  
9 Plaintiffs' Notice, they do not concede that the information requested is relevant to this action.  
10 Defendants expressly reserve the right to object to further discovery of the subject matter of the  
11 Notice and the introduction into evidence of any answer or portion thereof in response to this  
12 Notice.  
13

14           10. Each of the foregoing statements and/or objections is incorporated by reference  
15 into each and every specific response set forth below. Notwithstanding the specific responses  
16 below, Defendants do not waive any of their General Objections.

### 18                           **SPECIFIC OBJECTIONS AND RESPONSES TO NOTICE TOPICS**

#### 19           Topic 1:

20           Each of the "Directives" identified in the First Amended Complaint, including: (a) the  
21 1947 Nuremberg Code or law; (b) Wilson Directive; (c) the Belmont Report; (d)  
22 Executive Order No. 12333 identified in Paragraph 116 of the First Amended Complaint  
23 (e) the June 30, 1953 DOA Confidential Memorandum identified in Paragraph 118 of the  
24 First Amended Complaint; (f) the Common Rule; (g) Army Regulation 70-25; and (h) any  
25 other regulation, directive or executive order CONCERNING consent and/or informed  
26 consent that relates in any way to the TEST PROGRAMS.  
27  
28

1 OBJECTIONS AND RESPONSE

2 Defendants object to Topic 1 insofar as it calls for a legal opinion, encompasses  
3 information that is as irrelevant and seeks information not reasonably calculated to lead to the  
4 discovery of admissible evidence, and is cumulative of Topic 39.

5 Subject to this objection and Defendants' General Objections, Defendants designate Dr.  
6 Arthur Anderson, who will testify regarding the Nuremberg Code, Wilson Directive, Army Reg,  
7 70-25 and ethics of human testing.  
8

9  
10 Topic 2:

11 The interface between and representatives involved in contacts between YOU and the  
12 DVA regarding death and disability claims brought by TEST SUBJECTS.

13  
14 OBJECTIONS

15 Defendants object to Topic 2 on the ground that it is irrelevant and seeks information not  
16 reasonably calculated to lead to the discovery of admissible evidence.

17  
18 Topic 3:

19 Each instance in which a veteran claimed to be involved in one or more of the TEST  
20 PROGRAMS, but YOU informed anyone, including the DVA, that YOU had no record of  
21 such participation.

22 OBJECTIONS

23 Defendants object to Topic 3 on the ground that it is irrelevant and seeks information not  
24 reasonably calculated to lead to the discovery of admissible evidence, and seeks information not  
25 known or reasonably available to Defendants.  
26  
27  
28

1           Topic 4:

2           Studies of and other information CONCERNING the potential health effects of exposure  
3           to chemical and/or biological weapons tested as part of the TEST PROGRAMS, and each  
4           of them.

5           OBJECTIONS AND RESPONSE

6           Defendants object to Topic 4 to the extent it seeks information not known or reasonably  
7           available to Defendants.

8           Subject to this objection and Defendants' General Objections, Defendants designate Dr.  
9           Michael Kilpatrick, OSD (HA/TMA) (Strategic Communications), who will testify as to the fact  
10          sheets that DoD has generated as to health effects of some of the substances used during the  
11          chemical and biological testing programs at Edgewood and Ft. Detrick.

12  
13  
14          Topic 5:

15          The protocols, conduct, administered doses, dose-response data, and mode of exposure for  
16          each of the TEST PROGRAMS, including sub-projects.

17          OBJECTIONS AND RESPONSE

18          Defendants object to Topic 5 to the extent that it seeks information that is irrelevant and  
19          not reasonably calculated to lead to the discovery of admissible evidence and that is seeks  
20          information not known or reasonably available to Defendants.

21          Subject to this objection and Defendants' General Objections, Defendants designate Dr.  
22          Dr. James A. Baker, Associate Director of Edgewood Chemical Biological Center, who will  
23          testify regarding information reasonably available in the Edgewood Arsenal technical library.

24  
25  
26          Topic 6

27          CIA involvement in the TEST PROGRAMS, including without limitation, identification  
28          of chemical or biological agents, use of undercover agents, financial support, direction,

1 field testing, operations, and the results of any evaluation of each chemical substance or  
2 biological agent.

3 OBJECTIONS AND RESPONSE

4 Defendants objects to Topic 6 as overly broad for the reasons stated in Defendants'  
5 objection to the definition of "TEST PROGRAMS." Defendants further object to the topic as  
6 overly broad as well as unduly burdensome insofar as CIA "involvement" is defined to include  
7 "without limitation, identification of chemical or biological weapons, use of undercover agents,  
8 financial support, direction, field testing, operations and the results of any evaluation of each  
9 chemical substance or biological agent" and encompasses information that is irrelevant and seeks  
10 information not reasonably calculated to lead to the discovery of admissible evidence, and may be  
11 subject to the state secrets or other privilege. Defendants further object insofar as the topic  
12 encompasses information that is not known or reasonably available to Defendants. In addition to  
13 the passage of more than thirty-five years, the CIA's relationship with Edgewood Arsenal and  
14 Fort Detrick was unusually tightly compartmented, and as Plaintiff's complaint notes, personnel  
15 involved maintained a policy against the creation of written records. Given these limitations and  
16 that those individuals with percipient knowledge are deceased or retired, there is no basis on  
17 which a CIA designee could fully educate himself or herself regarding agency participation  
18 beyond the documents produced or to be produced in this litigation.

21 Subject to this objection and Defendants' General Objections, Defendants state that they  
22 designate Patricia Cameresi, Associate Information Review Officer, CIA, to testify regarding the  
23 CIA's involvement, if any, in the specified test programs and other chemical or biological testing  
24 involving service members conducted at Edgewood Arsenal or Fort Detrick, based solely upon  
25 non-privileged, unclassified information contained in the documents produced in this litigation.  
26

Topic 8

The incidence of death and disease for participants in the TEST PROGRAMS, and each of them, including each sub-project. See Medline, medical publications, handbooks, IOM study and NRC reports, Borden Handbooks and CRC Press books.

OBJECTIONS AND RESPONSE

Defendants object to Topic 8 on the ground that it is overbroad insofar as it is not limited to military servicemembers or veterans and encompasses information not known or reasonably available to Defendants.

Subject to this objection and Defendants' General Objections, Defendants state that they have no knowledge of military servicemembers or veterans whose death has been attributed to participation in chemical or biological testing by the military.

Topic 9

The legal and other requirements associated with informed consent, and/or their application to military personnel.

OBJECTIONS AND RESPONSE:

Defendants object to Topic 9 to the extent that it calls for a legal opinion.

1 Subject to this objection and Defendants' General Objections, Defendants designate Dr.  
2 Arthur Anderson, MD, of the U.S. Army Medical Research Institute of Infectious Disease  
3 ("USAMRIID"), Office of Human Use and Ethics, to testify on the ethics of human testing.

6 Topic 10

7 The authorship, creation, and approval of the 1963 Report of Inspection of MKULTRA by  
8 CIA Inspector General J.S. Earman ("1963 CIA IG Report"), identified in Paragraph 107  
9 of the First Amended Complaint and attached to the First Amended Complaint as Exhibit  
10 B.

11 OBJECTIONS

12 Defendants object to Topic 10 on the ground that it is irrelevant and seeks information not  
13 reasonably calculated to lead to the discovery of admissible evidence, and seeks information  
14 protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g.

15  
16 Topic 11

17 The PERSONS contacted or interviewed in connection with the 1963 CIA IG Report and,  
18 the notes, comments, analysis or other writing CONCERNING its contents.

19 OBJECTIONS

20 Defendants object to Topic 11 on the ground that it is irrelevant and seeks information not  
21 reasonably calculated to lead to the discovery of admissible evidence, and seeks information  
22 protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g.

23  
24 Topic 12

25 The provisions of the Nuremberg Code and its application to the TEST PROGRAMS.  
26  
27  
28

1 OBJECTIONS AND RESPONSE:

2 Defendants object to Topic 12 insofar as it calls for a legal opinion, encompasses  
3 information that is as irrelevant and seeks information not reasonably calculated to lead to the  
4 discovery of admissible evidence.

5 Subject to this objection and Defendants' General Objections, Defendants designate Dr.  
6 Arthur Anderson, who will testify regarding the Nuremberg Code and ethics of human testing.  
7

8  
9 Topic 13

10 The medical files and databases CONCERNING each participant in the TEST  
11 PROGRAMS.

12 OBJECTIONS AND RESPONSE:

13 Defendants object to Topic 13 insofar as it encompasses information not reasonably  
14 known to Defendants and information is protected by the Privacy Act, 5 U.S.C. § 552a, the  
15 Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), 42 U.S.C. § 1320d-2,  
16 the HIPAA Privacy Rule, and/or 45 C.F.R. parts 160 and 164.  
17

18 Subject to this objection and Defendants' General Objections, Defendants designate Mr.  
19 Lloyd Roberts (USAMRICD), who will testify about medical files and databases at Edgewood.  
20

21 Topic 14

22 The scope and conduct of the search for documents pursuant to requests from Congress in  
23 connection with hearings of the Church Committee in 1975 (see Final Report of the Select  
24 Committee to Study Governmental Operations with Respect to Intelligence Activities, S.  
25 Rep. No. 94-755, 94th Cong., 2d Sess., Book I, § XVII ("Foreign and Military  
26 Intelligence: Testing and Use of Chemical and Biological Agents by the Intelligence  
27 Community") (1976)), the Pike Committee in 1975-1976 (House Select Committee on  
28 Intelligence) and other committees and subcommittees in 1975-1977 related in any way to  
the TEST PROGRAMS (see, e.g., Biomedical and Behavioral Research, 1975: Joint  
Hearings Before the Subcomm. On Health of the S. Comm. On Labor and Public Welfare

20 effects, and the effects associated with each pathway of exposure, including, without  
21 limitation, external, inhalation, absorption, or dermal.

22  
23 OBJECTIONS AND RESPONSE

24 Defendants object to Topic 15 to the extent it seeks information not known or reasonably  
25 available to Defendants.

26 Subject to this objection and Defendants' General Objections, Defendants designate Dr.  
27 Kipatrick, who will testify generally about the health effects described in the topic and to the  
28 extent that such information is known or reasonably available to Defendants.

10 them, and the benchmarks or levels of dose where specific types of effects are apparent,

12 response relationship, and the estimated dose that would induce death, the so-called "man-  
break" dose.

13 OBJECTIONS

14 Defendants object to Topic 17 on the ground that it seeks information not known or

25 U.S.C. § 1320d-2, the HIPAA Privacy Rule, and/or 45 C.F.R. parts 160 and 164.

3 associated referral process.

7 The Memorandum for the Record identified in Paragraph 162 of the First Amended  
8 Complaint.

9 OBJECTIONS

10 Defendants object to Topic 19 on the ground that it is irrelevant and seeks information not  
11 reasonably calculated to lead to the discovery of admissible evidence, and seeks information  
12 protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g.  
13

14 Topic 20

15 Contracts, contract proposals, contract approvals, and payments for each task or role  
16 performed by a third party (such as a contractor or university researcher) CONCERNING  
17 the TEST PROGRAMS, including each sub-project.

18 OBJECTIONS

19 Defendants object to Topic 20 on the ground that it is irrelevant and seeks information not  
20 reasonably calculated to lead to the discovery of admissible evidence, and seeks information

6 Runo Richardson of OCLL [KELLY: WHAT DOES OCLL STAND FOR?], who will testify  
7 generally regarding communications between DoD and Congress concerning military chemical  
8 and biological testing.

12 The IDENTITY of all cut-outs (as defined in Paragraph 130(a) of the First Amended  
13 Complaint) used in connection with the TEST PROGRAMS, including each sub-project.

14 OBJECTIONS

15 Defendants object to Topic 22 on the ground that it is irrelevant and seeks information not  
16 reasonably calculated to lead to the discovery of admissible evidence, and seeks information  
17 protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g.

21 The activities of each PERSON used as a cut-out (as defined in Paragraph 130(a) of the

Approvals sought and/or given by anyone in connection with the TEST PROGRAMS, including each sub-project.

OBJECTIONS

Defendants object to Topic 25 on the ground that it is irrelevant and seeks information not reasonably calculated to lead to the discovery of admissible evidence.

Topic 26

The report CONCERNING covert activities of the CIA identified in Paragraph 111 of the First Amended Complaint.

OBJECTIONS

Defendants object to Topic 26 on the ground that it is irrelevant and seeks information not reasonably calculated to lead to the discovery of admissible evidence, and seeks information protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g.



1           Topic 27

2           The general design, development, planning, methodology, operation, and use of mind  
3           control techniques or substances by YOU or anyone acting under YOUR control,  
4           supervision, financing or direction.

5           OBJECTIONS

6           Defendants object to Topic 27 on the ground that it is irrelevant and seeks information not  
7           reasonably calculated to lead to the discovery of admissible evidence, and seeks information  
8           protected pursuant to the Central Intelligence Agency Act of 1949, 50 U.S.C. § 403g.

9  
10           Topic 28

11           Experiments conducted by YOU or anyone acting under your supervision, financing or  
12           direction involving the release of chemical or biological substances into domestic  
13           environments such as cities, the atmosphere, rivers or lakes, or any other place.
